MODE D'EMPLOI

Dosage :

Typical dosage: **0.3 – 1.5 kg per 100 kg of cement**

- Chryso® Optima 1325 is completely miscible in water and must be added to the **mixing water**
- Concrete should be mixed thoroughly until a homogeneous mix is achieved

The optimum dosage must be established through trial mixes, taking into account local materials, site conditions, required workability, and target mechanical properties.

PRÉCAUTIONS

- Store away from frost
- If frozen, the product will recover its properties after thawing and thorough agitation
